COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-1st Degree-Great Bodily Harm

Minnesota Statute: 609.221.1, with reference to: 609.221.1, 609.101.2

Maximum Sentence: 20 YEARS AND/OR \$30,000

Offense Level: Felony

Offense Date (on or about): 05/22/2018

Charge Description: That on or about 5/22/2018, in Hennepin County, Minnesota, Corey David Burfield, assaulted M.D. and inflicted great bodily harm.

COUNT II

Charge: Assault-3rd Degree-Substantial Bodily Harm

Minnesota Statute: 609.223.1, with reference to: 609.223.1, 609.101.2

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 05/22/2018

Charge Description: That on or about 5/22/2018, in Hennepin County, Minnesota, Corey David Burfield assaulted M.D. and inflicted substantial bodily harm.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about May 22, 2018, a Student Resource Officer (SRO) assigned to Harrison High School, located at 501 Irving Avenue North, in the city of Minneapolis, Hennepin County, Minnesota, was seated in the main office with a view of the hallway when he observed COREY DAVID BURFIELD, DOB: 03/26/2000, Defendant herein, approach M.D., Victim herein. The SRO observed Defendant knock Victim to the ground and punch him a number of times before he was forcibly removed and walked away. Victim was left unresponsive. When emergency personnel arrived on scene, they assessed the situation and determined that life saving measures were necessary. Victim was transported to the hospital where he was listed in critical condition. Witnesses observed the assault.

Surveillance video of the incident depicted the following: Defendant approaches Victim and makes a grab for his belt where his school radio and keys to the building are kept. Victim attempts to push Defendant away and Defendant grabs Victim by the shirt and shoves him first into a wall and then down to the ground where he strikes Victim numerous times about the head and neck with a closed fist.

In speaking with officers, Defendant claimed that Victim "took a swing" at him and he was only defending himself.

Defendant is presently in custody.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
