Narrative

I was dispatched to the above address in Shorewood for the report of a neighbor dispute. Dispatch advised that the RP was reporting that his neighbor is yelling at the RP's wife on their property. I was familiar with the on-going disputes, and when I arrived I observed Mr. McMasters and Mr. Gleason standing in Mr. McMaster's yard. I approached them and asked them to tell me what was going on. McMaster's stated that his neighbor, Mrs. Catain, had come out of her house and began to yell at him while he was talking to several construction workers that were working on the Catain's property. McMaster's stated that he was talking to the workers about the condition of the access road, and the fact that all of the construction traffic has created ruts in the road. McMasters also stated that he was having a pleasant conversation with the workers, and that he was not being argumentative towards them. He stated that Mrs. Catain came out and began to yell at him telling him to stay off her property and was yelling at the workers not to talk to him. He stated that emotions got high, and she was calling him names and flicking him off. McMasters stated that he raised his voice to her as well, but could not remember exactly what was said.

It was at this time that the RP came driving towards his residence. Mr. Catain was yelling out the window while he was driving, and stated, "You wanna come after my wife?". Mr. Catain was extremely agitated and began to walk up to us while he was yelling and swearing. I repeatedly asked him to stay by his vehicle and that I would speak to him in a moment. He continued to walk towards me, and yelled to Mr. McMasters, "You wanna come after my wife? You wanna try to hit her? I'll fucking kill you." At that time I ordered Mr. Catain back to his vehicle and requested assistance from dispatch. Mr. Catain continued to walk towards me, and Mr. Gleason began to yell back at Mr. Catain. At one moment I was directly in between the two of them while they continued to yell at each other and disregard my commands to walk away. I then turned to Mr. Gleason, placed my hand on his chest and asked him to go to his residence and not to return. Mr. Gleason did as he was asked, and Mr. Catain continued to yell and swear.

I then directed my attention to Mr. Catain and began to back him towards his vehicle and again ordered him to stay by his vehicle. Mr. Catain then did as he was asked and stood by his Jeep. At this time Officers from the Mound and Minnetrista Police Departments began to arrive.

I finished my conversation with Mr. McMasters who appeared to be aggravated by the situation. I advised him that if there is a problem again, to go inside and call the Police. He stated that he would and then asked if he could leave the residence. I advised him that he could and he left.

I then went back to speak with Mr. Catain again. He was still very upset, and I advised him that it was completely out of line for him to approach us in the manner that he did. He stated that it was not right for McMasters to threaten his wife. I agreed and told him that I was there to get both sides of the story, and that I will speak to him and his wife if he calms down. I then asked that we go and speak near his residence. He agreed and we went down bear his garage.

I then spoke with Mrs. Catain who stated that she was looking outside when she saw that Mr. McMasters was talking with her workers. She stated that she went out there and told him that if he has anything to say, to say it to her. She stated that McMasters was in his vehicle, and that it was pulled up at an angle to her driveway. She stated that he said to her, "Don't you have some meds to go take." Mrs. Catain stated that she got upset and told him to, "Stay away you old

goat.", and that she then flicked him off. Mrs. Catain stated that he made a motion as though he was going to get out of his vehicle, and that she felt threatened by the way he was talking to her. I asked her if she thought he was about to hit her, and she stated that she did not know what he was capable of. I then asked her if she told her husband that Mr. McMasters threatened to hit her, and she said, "No." I asked her if she knew how her husband got the miscommunication that Mr. McMasters threatened her and she stated that she did not know.

Mr. Catain then stated that he knows MN Attorney General Mike Hatch, and that he has made enough contributions to him to get a favor. He stated that he was going to call "Hatch" and get a restraining order and get "Them" out of Shorewood. I cautioned Mr. Catain on his temper and advised him that in the future, he can not let his emotions take over to that extreme. He stated that he understood, and agreed that there would not be any problems after I left the area.

After speaking with Mr. Catain, I spoke to several workers who were in the area at the time. They stated that they did not want to get involved, but did make comments that it appeared to be a misunderstanding, and that Mr. McMasters was not being argumentative when he was speaking to the workers on site. They did not wish to comment any further.

I then spoke again to Mr. Gleason. I advised him of the same thing, asking him to just go inside and call the Police if there is another altercation like that again. Mr. Gleason agreed and stated that the last thing he wants is to get into a fight with Mr. Catain. Mr. Gleason also stated that he wished there was a way that they could all just talk civilly with each other, and agree to leave each other alone and live peacefully. Mr. Gleason agreed that if I left, there would be no further problems.

After all parties went their separate ways, Officers cleared the area. No parties involved wished to pursue any charges.

No further action taken at this time.
